



FITTING INSTRUCTIONS

- Loosen the two bolts securing the pillion foot rest, shown in picture 1. Do not remove completely.
- Remove the bolt securing the exhaust to the foot rest (shown in picture 2), supporting the exhaust silencer appropriately throughout.
- Remove the pillion footrest.
- Offer up the exhaust hanger to the bike, and secure in place using two M8 x 20mm bolts and washers provided (shown in Picture 3).
- Secure the exhaust to the hanger using the remaining M8 x 20mm bolt and washer and re-use the OEM M8 nut (shown in Picture 4).

Please note that it is your responsibility to ensure that no part of the exhaust hanger or exhaust assembly fouls or comes into contact with other parts of the machine. 
