


FITTING INSTRUCTIONS FOR BLP0038BK REAR FOOTREST BLANKING PLATE FOR APRILIA RSV4 '09- & TUONO '15-



THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)





Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

TOOLS REQUIRED

• 3 & 6mm metric Allen key.

Fitting Instructions

- Remove the two bolts that secure the pillion footrests in place on both side of the bike. The footrest hangers should now come away from the bike.
- Position smaller bolt supplied through the central hole so the head of the bolt fits into the counterbore of the blanking plate and offer it up to the bike. Tighten the bolt ensure the thread engages with the J-clip mounted on the plastic bodywork.
- With this bolt holding the blanking plate loosely in place, fit the two larger bolts through the blanking plate holes and tighten into the threaded bosses on the subframe.
- Repeat the above process to fit the blanking plate to the other side of the bike.
- Ensure all bolts are tightened evenly.



• Clé Allen 3 & 6mm.

Instructions de montage

- Enlever les 2 boulons qui fixent les repose pied passager en place de chaque coté de la moto. Les supports repose pied doivent à présent être enlevés de la moto.
- Positionner le boulon plus petit fourni dans le trou central de façon à ce que la tête du boulon se place dans le contre alésage de la plaque d'obturation puis montez la sur la moto. Serrer le boulon en veillant à ce que le filetage soit engagé avec le J-clip monté sur le cache en plastic.
- Une fois que le boulon maintient la plaque d'obturation en place, insérer les 2 grands boulons dans les trous de la plaque d'obturation puis serrer dans les patrons filetés du passage de roue.
- Répéter cette procédure pour l'installation de l'autre coté de la moto.
- Veiller à ce que tous les boulons soient serrés.
