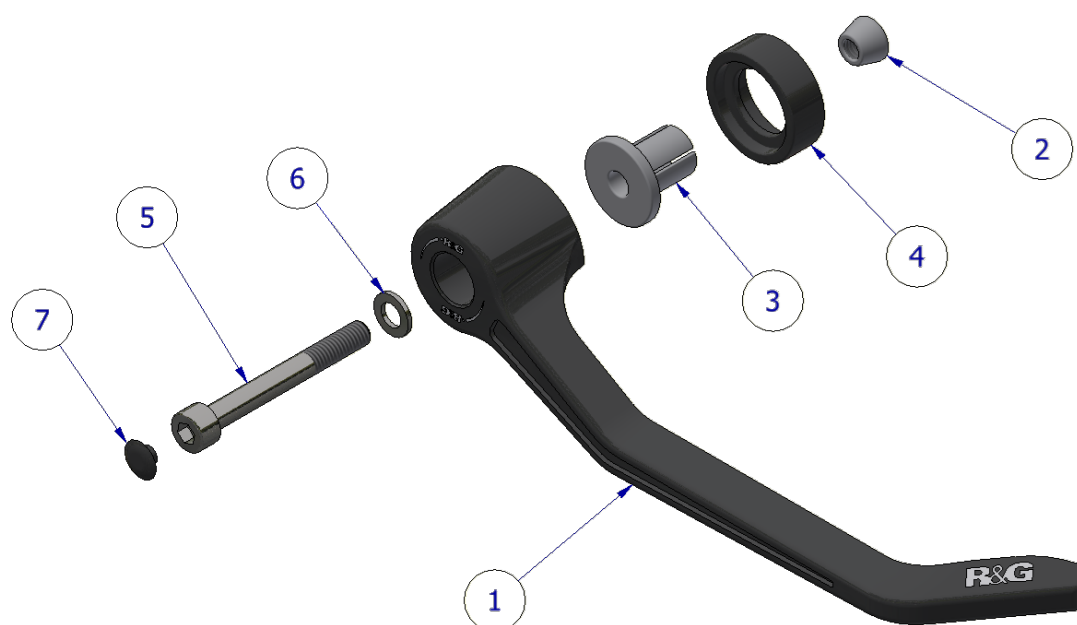

FITTING INSTRUCTIONS

- To fit the R&G Brake Lever Guard, you will need to remove the original bar-end using the specific tools for your bike. Place the M6 washer (**item 6**) over the M6 cap-head bolt (**item 5**), then slide through the brake lever guard (**item 1**) so the washer sits against the flat surface within the mounting counter-bore.
- Place the expander (**item 4**) over the thread and up to the lever guard so the larger diameter sits against the lever guard.
- Place the spacer (**item 3**) over the expanding spacer with the shallow counter-bore against the expanding spacer.
- Place the tapered nut (**item 2**) onto the thread and engage until it locates in the expander just fitted.
- Locate the lever guard assembly into the bar and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle.
- Using a 5mm Allen tool, fully tighten the bolt and check operation.
- Finally, push the flat cap (**item 7**) into the head of the cap-head bolt.

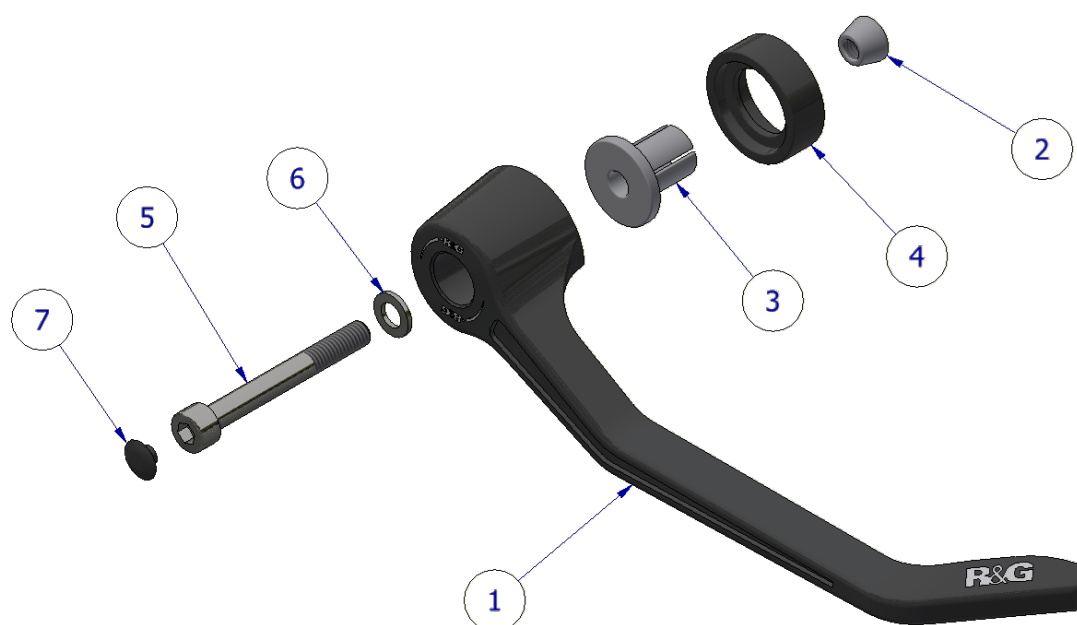

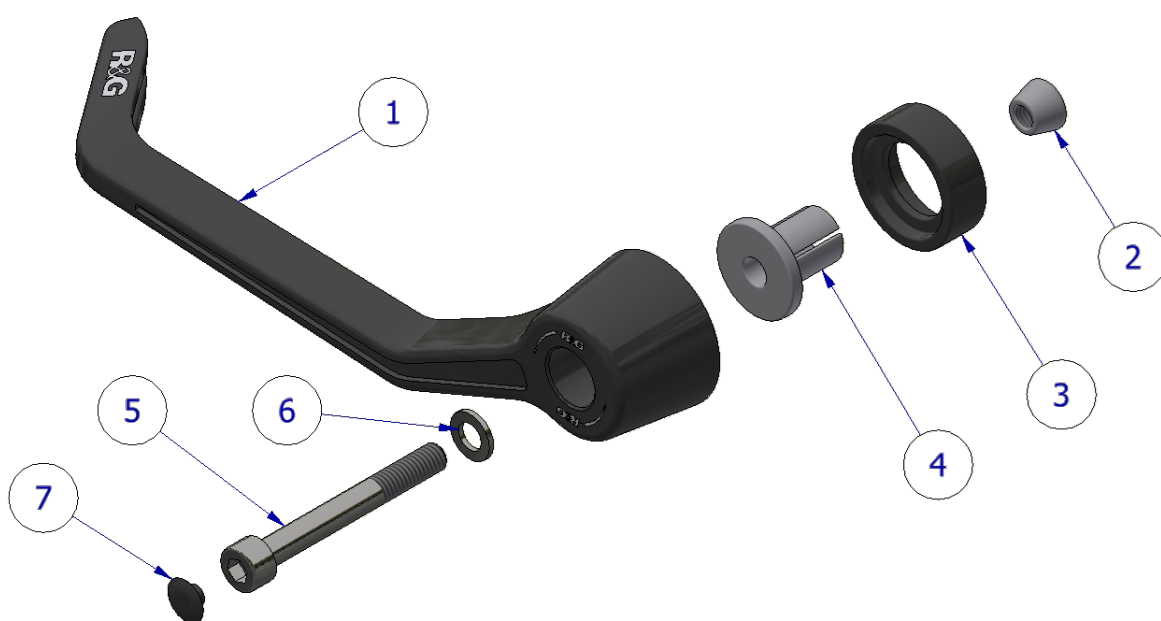

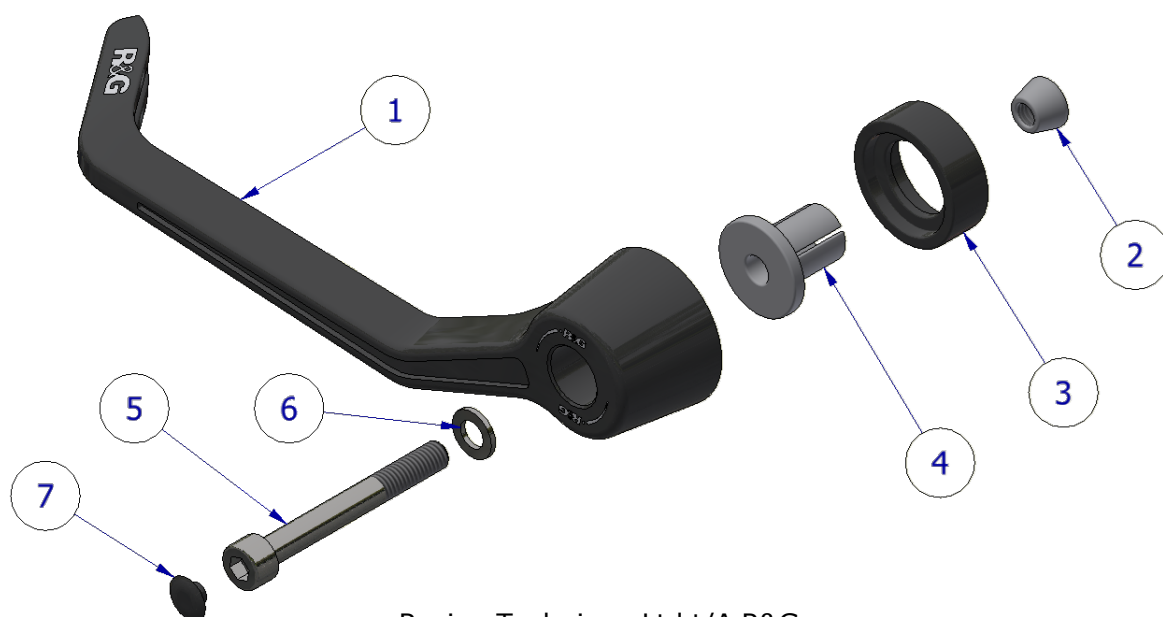
