This Kit contains the items pictured and labelled over page. Some parts may be shown for clarity of instructions only. Do not proceed until you are sure all parts are present. Please read all instructions before proceeding.

## **FITTING INSTRUCTIONS**

- Carefully pass the clamping plate (**Item 2**) around the side stand leg with the countersinks facing upwards.
- Take the machined aluminium mounting plate (**Item 1**) and fit to the base of the side stand from underneath.
- Sandwich the two plates together around the side stand pad.
- Apply a small amount of Loctite blue 242 to the threaded end on each of countersunk bolts (**Item 3**).
- Fit the three bolts (**Item 3**) through the clamp plate and into the mounting plate clamping the two plates securely together to the side stand pad.
- Tighten all the bolts evenly and ensure the stand is clear of the swingarm and chain when in the raised position.
- If fitting to older side stands that have a lot of wear, the self-adhesive foam strip (**Item 4**) should be cut and placed into the base plate to ensure a tight fit.

# **NOTICE DE MONTAGE**

- Passez avec précaution la plaque de serrage (Article 2) autour du pied de la béquille latérale avec les fraisures vers le haut.
- Prenez la plaque de montage en aluminium usinée (Article 1) et fixez-la à la base de la béquille latérale par le dessous.
- Enserrez les deux plaques ensemble autour du rembourrage de la béquille latérale.
- Appliquez une petite quantité (une goutte) de bleu Loctite 242 sur l'extrémité filetée de chaque boulon à tête fraisée (article 3).
- Montez les trois boulons (Article 3) à travers la plaque de serrage et dans la plaque de montage en serrant solidement les deux plaques ensemble sur le rembourrage de la béquille latérale.
- Serrez tous les boulons uniformément et assurez-vous que la béquille soit dégagée du bras oscillant et de la chaîne lorsqu'elle est en position relevée.
- En cas d'installation sur des supports usagés plus anciens, la bande de mousse adhésive (article
  4) doit être coupée et placée sur la plaque de base pour assurer un ajustement serré.
