

TOOLS REQUIRED

- 3mm A/F Allen key or bit.
- Thread locking compound.

GENERAL TORQUE SETTINGS

- M4 BOLT = 8Nm
- M5 BOLT = 12Nm
- M6 BOLT = 15Nm
- M8 BOLT = 20Nm
- M10 BOLT = 40Nm
- M12 BOLT = 40Nm

FITTING INSTRUCTIONS

- Take the machined aluminium mounting plate (**item 1**) and fit to the base of the side stand from underneath.
- Pass the clamping plate (item 2) around the side stand leg with the countersinks facing upwards.
- Sandwich the two plates together around the side stand pad.
- Apply a small amount of (one drop) of thread locking compound to the threaded end of each countersunk bolts (item 3).
- Fit the four bolts (**item 3**) through the clamp plate and into the mounting plate, clamping the two plates securely together to the side stand pad as shown in the assembly diagram on page 1.
- Tighten all the bolts evenly and ensure the stand is clear of the swingarm and chain when in the raised position.
- If fitting to older used stands that have wear, the self-adhesive foam strip (**item 4**) should be cut and placed into the base plate to ensure a tight fit.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
