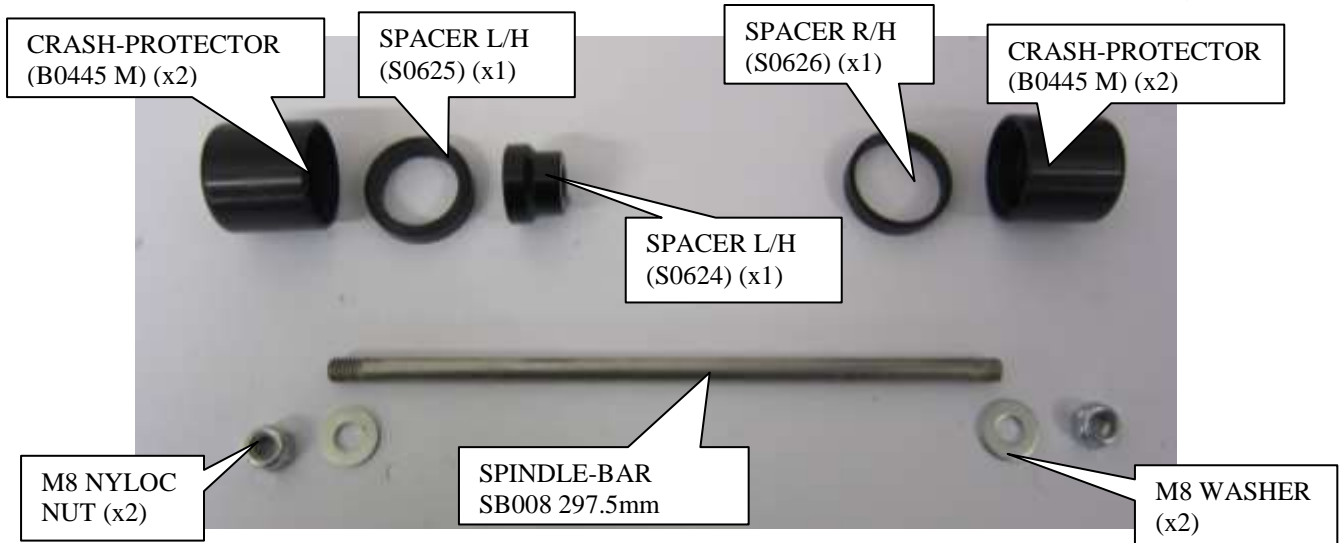

TOOLS REQUIRED

- Socket set to include 2x 13mm sockets and wrenches

FITTING INSTRUCTIONS

- Fit one nut and washer on spindle-bar (SB008) (the end with shorter thread), engage the nut so the plastic insert of nut is fully engaged.
- Feed spindle-bar with nut and washer through either crash protector (B0445 M) and through the metal spacer (S0624), as shown in the above picture.
- Place the tube type spacer with the smaller bore (S0625) over the original spindle on the left hand side.
- Place this assembly through the front wheel spindle from the left hand side, ensuring the metal spacer fits into the wheel spindle.
- Place the remaining spacer (S0626) and crash protector over the exposed end of the spindle bar on the right hand side. The spacer should locate over the original spindle nut.
- Fit washer and nut from kit onto thread and tighten until both nuts are engaged in nylon and equal amounts protrude from either side (please ensure the logo is located at the top of the crash protector). Do not overtighten – the nyloc nuts will hold it tight.

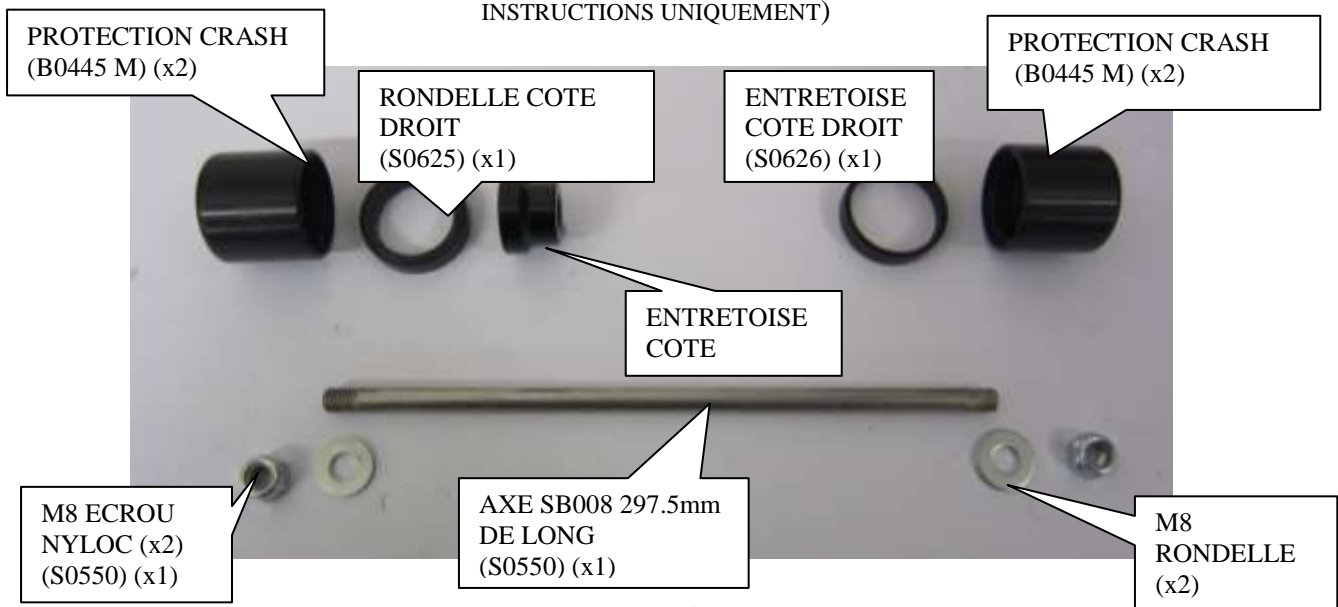

OUTILS REQUIS

- Clés plates 2x 13mm

Instructions de montage :

- Insérer un écrou et une rondelle sur l'axe (SB008) (l'extrémité avec le filetage le plus court), engager l'écrou de façon à ce que l'insert en plastique de l'écrou soit complètement engagé.
- Passer l'axe avec écrou et rondelle à travers la protection crash (B0445 M) et à travers l'entretoise en métal (S0624), (photo du haut).
- Placer l'entretoise (S0625) autour de l'axe du côté gauche.
- Placer l'ensemble à travers l'axe de roue avant du côté gauche, en vous assurant que l'entretoise en métal se place bien sur l'axe.
- Placer l'entretoise restante (S0626) et la protection crash autour de l'axe du côté droit. L'entretoise devrait se placer autour de l'écrou d'axe.
- Insérer la rondelle et l'écrou du kit sur le filetage puis serrer jusqu'à ce que les 2 écrous soient engagés dans le Nylon et dépassent de la même longueur de chaque côté de la moto (assurez vous que le logo soit placé vers le haut de la protection crash). NE PAS BLOQUER – les écrous de nyloc fixent l'ensemble.
