



## FITTING INSTRUCTIONS FOR CP0202BL/WH LOWER CRASH PROTECTORS YAMAHA YZF R6 '06 ONWARDS



**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

- Take the R&G bar and slide it through the swing arm pivot bolt.
- On the RHS take the longer aluminium spacer and slide it over the bar (small diameter towards the bike) and locate into the hexagonal shaped end of the pivot bolt. Take one of the protectors and slide over the bar followed by one of the 10mm washers then one of the nyloc nuts.
- On the LHS slide the shorter spacer on to the bar and up to the end of the pivot bolt (so smaller spigot locates into spindle), followed by the protector, washer and nyloc nut. Please note the thin sectioned counter bore on inboard side of bobbin is cosmetic only and does not have any bearing on strength or operation of bobbin.
- With a socket on either end of the bar, tighten the assembly. **DO NOT TIGHTEN ABOVE 40nm** as you will strip the threads on the bar/nut
- When the assembly is tight push the end caps into both protectors.
- **PLEASE NOTE BOBBIN MUST BE POSITIONED HORIZONTALLY AS SHOW ABOVE**

### R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P - at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
